B. Bounty Hunter will get paid in a timely manner of 10 days after the verification of the surrender is confirmed.

C. If Bounty Hunter goes unpaid accounts of Listing Agents may be terminated or suspended until payment is made. Listing Agents agree to pay Attorney fees plus interest, if filing suit becomes necessary, due to nonpayment.

D. If you decide to terminate your listing within 30 days of submission, NO refund will be issued.

All services provided by Fugitive Database may be used for lawful purposes only. Transmission, storage or presentation of any information, data or material in violation of any United States Federal, State or City law is prohibited.
